



Witnessest that I the said David Curtis for and in consideration of the sum of Eight pounds to me in hand paid by the said Jesse Holton the receipt whereof is hereby fully acknowledged I the said Curtis hath granted Bargained and sold unto him the said Jesse Holton and his heirs for ever certain pieces or parcels of land containing by Estimation Eight acres be the same more or less lying and being in the County of Craven on the North side of Bay river and north side of Rack-
-une creek bounded as follows.
