This Indenture made and executed on this ... day of ... 1815. Between the said
eight hundred and forty nine by and between John and James Gaskins, Mary and
Elizabeth Rowe, Hannah Everington, Betsy Fulshire, and Benelope Toler of the County
of State of North Carolina of the one part, and James Swirell of the aforesaid County,
and State of the other part, Witnesseth that the said John and James Gaskins, Mary and
Elizabeth Rowe, Hannah Everington, Betsy Fulshire, and Benelope Toler for and in con-
sideration of the sum of Thirty five Dollars to them in hand paid by the said James Swirell
with the receipt whereof is hereby acknowledged hath granted bargained and sold and
by these presents doth grant bargain and sell to the said James Swirell his heirs and as-
signs all of their the said John and James Gaskins, Mary and Elizabeth Rowe, Han-
nah Everington, Betsy Fulshire and Benelope Toler right title and interest in and
to one half of a certain tract of land lying in aforesaid County and State on the North
side of New river and East side of Great swamp and adjoining the lands of Enoch
Swirell, Thomas Swirell and others consisting of three patents here granted to Hannah
Gaskins one dated April 26th 1761, the other dated September 13th 1757, one granted to
William Beasley dated September 26th 1753, To have and to hold the aforesaid undi-
vided interest in said land and premises to him the said James Swirell his heirs
and assigns forever, free and discharged from all incumbrance whatever, the parties
of first do covenant to and with the said James Swirell that they have before the ex-
ecution of these presents full right and absolute lawful authority to sell and convey
the aforesaid bargained premises to the said James Swirell his heirs and assigns
forever and do agree to warrant and defend the same to the said James Swirell his
heirs and assigns forever, from the lawful claims of all persons whatever, In wit-
ness whereof the parties of the first part, do hereunto set their hand and seal day and
date first above written.
